I. Preface

The "Holocaust Wars Project" was developed over the past two decades and is now being housed in a new company to be shortly formed –

The "Project Gideon Company" (PGC)

The PGC website "<u>https: projectgideoncompany.com</u>" provides an extensive "Knowledge Base" covering nearly all aspects re Holocaust.
At this time, it already includes 12 manuscripts consisting of
(1) Eyewitness stories, (2) Semi realistic fictional "Companion Books"
(3) Stories of defiance / resistance / heroic true stories and (4) Over 50
"Booklets" dealing with single issue educational treatments. It also includes (5) Numerous opinion pieces and critiques.

The Key Goals of PGC are:

- (1.) Improve the narrative re Holocaust by balancing pain and suffering with heroics emanating from Jews and non-Jews.
- (2.) Nail down what the Centennial Memorial should look like exactly, no ad-hoc concoctions.

Given numerous obstacles that need to be overcome, see website's booklets justification for this assertion.

- (3.) Prove the existence of an umbilical connection between pogroms / mass killings / atrocities / genocides and malignant Totalitarian minds infected by deterministic cults – <u>these are</u> <u>the midwives that made atrocities get to be a Holocaust.</u>
- (4.) Highlight the rise of Israel from the Holocaust's ashes to strengthen the unbroken connection between the world's Jewry and Israel. <u>And thus, make it understood by all that harming Jews is very, very costly for the perps</u>.
- (5.) Argue for the establishment of a "Jewish Medal of Honor" for non-Jews who helped Jews while facing extreme punishment for simple acts of kindness. For extraordinary feats, we argue for the "Titan of the Holocaust" medals.
- (6.) To pay respect to numerous groups / tribes / nations aggrieved by atrocities, we argue to export what by now turned out to be a Jewish loud cry "NEVER AGAIN" and make it "Go International."

We argue that billions of dollars have been and are still being spent on the world's largest ever research project, should involve learning about atrocities of Chinese against Tibetan, Russians against Ukrainians ("Sovietization"), slaughtered of a huge Polish Intelligencia by Nazis, Russians stood by when retreating Nazis slaughtered Polish troops. We argue that "NEVER AGAIN" going international will provide a voice to the voiceless aggrieved and will help to keep the U.N. away avoiding a useless event of speeches (to be nicely filed). See website. (7.) To minimize diplomatic entanglements, the advocacy of (6) above should not involve the major research centers, nor the helpless U.N. because of multiple reasons provided in the booklets of the Knowledge Base.

"Small Fry" like PGC can help in formulating the policy and suggest implementation with straightforward mini-plans.

With the above in mind, we start this little advocacy booklet by producing the following Author's Notes.

Note 1

Although none of the key founders of PGC is a trained historian that can adequately deal with sweeping weighty opinions, some generalizations we'll make are not farfetched. Among these are:

- (1.) Jews have placed learning and "Knowing" high on their agenda. It is quite logical to assume that, as a result, the Jews had over time some jump in their IQ over groups and cultures that didn't have a high emphasis or learning and knowing, or may have been prevented by near slavery to have any.
- (2.) Although the IQ measure is not the dominant measure of "Intellectual Superiority," it is known that many rulers in Europe, Asia and North Africa invited Jewish immigration to improve the management of economic activity in their realm.
- (3.) In many cases, probably in the majority of cases, the Jewish invitees were also <u>disinvited</u> whenever the rulers, on a whim, could transfer responsibility for any failure and blame on the Jews.
 "Disinvitation" was usually accompanied by harsh physical attacks on Jews.

(4.) In the 2000 years period since the destruction of the Second Temple, <u>Jews have characterized themselves</u> as victims, spread all over the civilized world, in small batches and considered, in most cases, as "Permanent Foreigners" by the local populations.

A strange phenomenon took hold. Jews lived in what can be described as ghettos. Most ominously, "Blood Libels" have been invented against them. In Christian countries, they were accused of killing the son of God, in Moslem countries, they were portrayed as the medina Jews who gave the Prophet Muhammed a hard time. In all domiciles, they were accused of utilizing children's blood on their Passover Matza, portrayed as super cheaters in all business deals, having horns after six p.m., being unsanitary, dirty and numerous other unseemly characteristics.

- (5.) It is not too farfetched that dislike / hatred / suspicions of Jews will lead to pogroms and massacres of Jews. It is also not hard to postulate that Jews will consider themselves as chosen people, chosen to suffer. How else could one explain the vast hatred, the prevailing mistreatment everywhere, relentless, unceasing and unjust.
- (6.) We leave it to our betters to explain the following phenomenon: In spite of significant hostility against Jews, and the long period of simmering hostility towards them, Jews did not "Disappear," their clinging to their religion and culture did not cease. They never gave up the dream of returning to Jerusalem "The Next Year" ...

Musings Note 2

The last 400 years, much has changed in the world. From the narrow view of a Jew, take my views for instance, the changes in the fate of the Jews were enormous.

The capitalist economic system induced huge leaps in science and technology, and for Jews who always valued learning and knowledge, opportunities opened up. Following upheavals in England, France, and other imperial powers created strong political and cultural demands by rising middle classes for human rights previously denied the governed masses.

Even in the most remote little towns, in backward Middle European towns, Jews woke up from a long dreamlike tough existence and who quickly organized an intellectual life and important social services (ranging from secular and religious education, political parties, welfare services).

It is, so it seems, that Jews welcomed waking up to the siren songs of a new opportunities' era.

One important measure – Nobel Prize winners shows an overwhelming proportion were won by Jews or by Jewish descenders. The following provides the amazing details.

(1.) Jews provide 0.2% of human population, yet they won 208 Nobels out of 930 awarded, constituted 22.4% of the prizes, or <u>111 times their</u> <u>share of the population.</u>

Even more striking are the Jewish share in the individual Nobel categories.

Note 3

In the past 400 years, multiple imperial powers ruled the world. Spain and Portugal have shown how miserable life can be made for conquered peoples. Great Britain, France and Belgium and Netherland in tow have, until recently, shown why conquered peoples developed anti colonial movements most advocating physical rebellions.

The old empires were joined by newer ones. These may easily be classified as sclerotic. Russia seems to have forever fought central and far east tribes, appended many of them to an empire ruled from the east in near slavery status. Prussia dreamed of imitating Western empires dreamed of unifying all the German states. Prussia succeeded and beat the French to prove their might.

The Ottoman Empire, the ruler of the Mideast, made corruption into an art form.

THE REASON FOR RECITING THE ABOVE IN GLORIOUS SET OF GEO-POLITICAL OUTCOMES IS TO LEAD TO THE 20TH CENTURY –

THE WORST CENTURY IN HUMAN HISTORY, WITH THE WORST CRIMES IN HISTORY, WITH THE WORST INTELLECTUAL REFUSE REMAINING – with much of such refuse dominating the minds and deeds of many governments and international political, economic, security and cultural institutions.

PGC has devoted extensive efforts to show how realistic is its view of the 20th Century's role in human history.

But what we already said is not enough. This leads us to Note 4.

Note 4

In Note 2, we pointed out that for 2000 years Jews spread to many regions in Western Asia, North Africa, Southern Europe. Then spread further and, in small clusters, went far and wide.

In all places, they were, in fact, a permanent foreigner. It is not farfetched that downtrodden local populations deemed such "Foreigners" with suspicion. When encouraged by religious and other prejudices, it is logical that irrational libels helped downtrodden peoples take out their frustrations on seemingly helpless Jews.

We leave to professionally trained historians to explain:

"Why is it that the closer we get to the 20th Century, the Jews witnessed increasing hostility and more severe physical attacks?"

[We are aware that the Muslim world was not always in a mood to beat up on Jews. Yes, so what?]

[We are aware that Jews were invited to England and to Poland and enjoyed respites of decent treatment. True, so what?]

PGC PRODUCED IN ITS "KNOWLEDGE BASE" AN OVERWHELMING ARGUMENT THAT THE 20TH CENTURY HAS GENERATED A MULTI-PRONG DISASTER FOR THE JEWS UNLIKE ANY OTHER (EXCEPT FOR THE BIBLICAL FLOOD)

Consider:

- (1.) We already postulated that Jews, as a "permanent foreigner," and a small minority, around their neck hanging blood libels and who refuse to disappear – all contributing to pogroms and permanent victimhood.
- (2.) We show, in multiple papers in the "Knowledge Base" that killing Jews wasn't a simple act. Even "Extermination" is not – on its own – a suitable term.

Extermination must include an obscene level of malignant mind generated mechanics to confuse the victims (we graphically explain). We detail the extreme level of preparation necessary to achieve the extermination that is effective / productive.

(3.) Consider the fact that it took the Nazis from September '39 to December '41 (about 750 days) to perfect the "Extermination Machine."

The table below demonstrates:

Total Number of Days	≈ 750	≈ 1,250
Total Jews Exterminated	≈ 140,000	≈ 5,560,000
Jews Exterminated per day	About 190	About 4,450

It is quite likely the Nazis killed more Polish Intelligencia per day in their prep period 9/1939 - 12/1941 than the Jews they targeted.

(4.) Among the most surprising aspects of the Holocaust is the management of extermination assigned to the SS. These "gentle souls" were, and probably still are, assumed to have been dimwits barking and listening to insane diatribes (a.k.a. orders) and having well-polished boots.

Nothing is further from the truth.

Consider the following Ph.D. load of the SS.

THE SS HAD BY FAR A LARGER, ON AVERAGE, THAN THE Ph.D. LOAD OF THE GERMAN POPULATION

(5.) PGC's Knowledge Base covers in some detail the role of two cartels in the phenomenal malignancy of Holocaust's extermination machinery. The eugenicists and psychiatrists – especially the German branches – are undoubtedly a Satanic branch of pseudo sciences aiming to improve the human race by: (a) Culling "Undesirables" / "subhumans" (b) Protecting Aryan blood purity from contamination – an existential requirement for the Aryan Reich and (c) Finding "Humane Ways / Means / Practices" to achieve these goals.

(6.) It is quite baffling to seriously search for answers to three main questions re: The Holocaust: What happened / How did it happen / Why did it happen. The first two have been thoroughly examined and more or less provide many components of the answers. PGC had produced key booklets directly explaining that the Herculean effort is eternally laudable, but so far, it is not good enough. We carefully outline the "Not good enough" aspects.

The toughest nut to crack is the third question (WHY?).

Without having a good handle on causality, it is tremendously difficult to grasp the scope / the depth / the mind malignancy that brought out from deep reservoirs previously unseen dementia.

PGC Founders have struggled and followed some possible leads. Several papers point out the role played by:

- (a.) The Psychiatric and Eugenics cartels
- (b.) The "Intellectual Refuse" generated by the Totalitarian / Deterministic cults with enormous powers / resources to subjugate peoples, while simultaneously are able to cloak their deeds and view with sweet utopian "Kool Aid."
- (c.) Three (yes, three) World Wars 1914, 1939, 1945 and several depressions.

PGC may never reach the holy grail of explaining why the Holocaust occurred. This may be for many reasons, an obvious one is that this nut is hard to crack, period. Ancillary reasons consist of the natural appeal of Totalitarian Kool Aid makes it possible, via adding the educational cartel into maintaining the sweetness of the Kool Aid.

Imagine an educational system where well-fed, well-bred young / idealistic people have absorbed since kindergarten the idea of changing the world (<u>NOW</u>!) using all necessary means (Yes, all!) to get rid of (a long list of <u>real or imaginary ills</u>, including being "uncomfortable") believing that the masses ("Lumpen Proletariat," deplorable / irredeemable!) who cannot grasp what is good for them and need guidance (NOW!).

The Above is an Abomination.

Let us return to the Jews and the 20th Century.

III. What really happened to Jews in the 20th Century?

The facts are not difficult to enumerate.

(1.) In spite of growing participation by Jewish Intelligencia in the economic / political / cultural lives in major European countries, they still remained "The Permanent Foreigners."

Churchill's biographer (Gilbert)) informs us all that riots against Jews were part of miners strikes (1926), and could have vastly increased antisemitism if Churchill didn't interfere.

The French were still in the Dreyfus antisemitic mood. The Russians had their revolutions of 1905 and 1917 and managed to produce "The Protocols of the Elders of Zion" which to this day perks up the lives of Jew haters.

The Jewish Intelligencia tried to mingle with the Left-Wing Totalitarians in Germany and in Russia, many Jewish achievers tried to shed religion and still others tried to realize a 2000 years dream of being a nation of their own in a land of their own. In the turmoil-laden early 20th Century, the city dwelling Jews tried everything political of the left variety and in the small-town enclaves of Poland, Ukraine, Lithuania, Latvia, Rumania and Hungary, they stayed mired in poverty and subjected to pogroms.

An especially ugly, large scale pogroms occurred in 1919 Ukraine. Ukraine has had an especially ugly history of large-scale vicious genocides, with the worst of them in 1919.

Preceding the Nazi Jew-extermination machine was fully and meticulously employed, the Soviet Union under Stalin's malignancy, have devised vicious Sovietization policies causing vast starvation in Ukraine.

As usual, Jews were bearing the brunt of guilt for supporting Sovietization in the Ukraine and the Balkans.

(2.) The First World War was the worst war ever in all the possible obnoxious criteria – dead, wounded, dislocated people, massive new weapons, weapons of mass destruction, unusual punishments for losers, and birth of utopian cults with massive adherends.

When the Great Depression hit, it seemed to all that the entire civilization is going down the drain. Even the mighty appearance of the U.S., near the closing of WWII, which saved Europe for the first time, seemed unable to stem the massive economic failures / dislocations.

When the Nazi regime had its debut in the Berlin Olympics (1936), nobody believed what this utopian cult can do.

A snapshot on May 8, 1945, disclosed what was done. The fact that the Nazi exterminated a massive number of Jews was known to all. Many researchers / observers of Nazi deeds in WWII knew precisely what was done to Jews because: (a) Numerous camps were near enough to crematoria to smell the deed (b) Awful people always like to tell us - semi normal people - what they like to do (c) Numerous cleanup crematoria operations participants (done by Slavs) must have talked (d) Allied intelligence services knew all along that many unsavory crimes are occurring (e) Polish intelligence, extremely skilled and well organized immediately upon the start that this knowledge and dissemination is very important and those who got the enigma machines could get the secret out (f) Not long past May 8, '45, he rations for German POW's was halved by Eisenhower (g) The Russian intelligence, passing multiple murder centers on the way to Berlin could not just quietly pass.

AT THE END OF THE DAY (MAY 8, 1945) MANY IMPORTANT CONCLUSIONS CAN BE DRAWN.

Musings IV. End of WWII Conclusions – Re: Jews

- (1.) In spite of the millennia of atrocities against them, Jews never gave up their distinctive marker as a separate group. One can speculate from now till doomsday what kept the Jews from simply giving up the "Cultural" component that made them unified, no matter how sizeable the batch was in the very numerous locations they dispersed to.
- (2.) PGC goes to great length in its Knowledge Base proving the enormity of the crimes committed by the Nazis in: (a) Unimaginable meticulous preparedness (b) Thorough, expensive, satanic, extermination methods applied by malignant minds (c) Stubbornness, clearly in the face of hurting military efforts encompassing huge logistics problems (d) Shortage of chemical and other raw material products and the potential acquisition of the mark of Cain which may not lend itself to be erased.

No other tribe, nor other nation, has ever been subjected to what the Jews absorbed and lived to tell about it.

(3.) In spite of absorbing the enumerated crimes, the Jews did not just go meekly to their demise. The well-known ghetto uprising – the Warsaw one – fought against Nazis for 27 days. France lasted 47 days.

On May 24, 1943, Brigade Commander Jurgen Stroop reported on the captured booty:

- 7 Polish pistols
- 1 Russian rifle
- 59 pistols of varying caliber

- 1 German rifle
- Several hundred hand grenades including Polish and handmade
- Several hundred incendiary bottles
- Homemade explosives
- Infernal machines with fuses
- A large amount of explosives

 Ammunition of weapons of all calibers including some machine gun ammunition.

PGC provides a large number of heroic deeds by Jews and non-Jews providing vast evidence for muscular defiance by effecting deeds of partisans, intelligence achievements and enormous resistance acts in all German conquered countries.

- (4.) Given the enormous crimes committed by the Nazis, the enormous changes in the fate of the Jews occurred quickly after May 1945:
 - (a.) Exactly three years later, the State of Israel was established on May 15, 1948.

Jewish volunteers from all over the world streamed steadily to participate.

(b.) The new Commander of the new Israeli Defense Force was Laskov, he fought in WWII as a Major in the British Army. He was one of tens of thousands of Jewish fighters in the Empire's Armies, many of whom were decorated heroes. The Kibbutz movement in Israel supplied superbly trained fighters and commanders, many of them trained by Orde Wingate (In WWII, General Wingate generated many famous victories (e.g., Burma).

The United States Jews supplied commanders (Marcus) and numerous volunteers <u>AND MOST IMPORTANTLY</u>, supplied the huge financing for weapons, aircraft, ships, and bribery money to get the supplies on time to Israel and save the country from being attacked by formal armies (Egypt, Jordan, plus others) and superbly trained (The Jordanian Arab Legion).

(c.) In the three years between 5/1945 and 5/1948, the Jewish organizations in the U.S. supported multiple incredible efforts to assemble the dispersed Jews in Europe creating a believable set of projects for recovering Jews from unequalled traumas in a lousy history.

V. What About the Unwise Jews

We have reached a point in our narrative where we start to take a peek at Jews who, in PGC's view, are not so wise.

- (1.) To start, I make the claim that <u>I earned</u> the right to express the opinions in this paper by virtue of:
 - (a.) Being a certified Holocaust survivor and having gone through at early childhood, obvious traumas of hunger, cold and fear in hiding and forest living – seems obvious to me as less traumatic than the fate of Jews who were camp dwellers.
 - (b.) From a very early age, starting age 7, in Salzburg, Austria, in a Nazi city (very clean too ...), my parents did the utmost possible to affect maximum recovery from any remnant aspect of trauma. Father made serious money in cigarette smuggling and I was tutored by university professors in languages, math and science. They were handsomely paid. For three full years, I was stuffed with languages (Latin, English, German) sciences and math and special Yiddishkeit knowhow tutored by a Rabbi.

Salzburg, being in the American Occupation Zone, was a center for displaced European population. Father insisted that at age eight I should travel by myself. After training with his supervision, I travelled by myself on Salzburg trams.

(c.) I have earned the right to the opinions in this little booklet NOT just as a human for free expression, but, <u>VERY</u> <u>CLEARLY</u>, by being an eyewitness to a pogrom on Jews in late 1945 in Wroclaw, Poland. I was 7 ½ years old. World War II was over – but Jewish blood, not clotted yet, was still flowing. My published autobiographical two-volume book ("Jacob's Odyssey") describes the event fully.

I was eight years old when I witnessed in Salzburg the beating of a religiously dressed Jew on a tram in the Nazi city of Salzburg. I tell this story in the book I referenced above.

(d.) I have earned the right to the opinions I express in this booklet by virtue of spending 12 years in Israel (arriving in December 1948, the year of its formation, age 10 ½).

Four of the twelve years I "Paid my Dues." I was a well-trained competent warrior. The last two years, I was a paratroop officer and a military intelligence officer on the Syrian border. I absorbed all the Marxism I could, being a member of the left-most Kibbutz in the country (Har-El, halfway between Tel Aviv and Jerusalem).

MY LOVE FOR ISRAEL IS BOUNDLESS.

(e.) I joined my parent in the U.S. in August 1960.

It didn't take very long to fall in love with America. First was due to economics.

- In just two weeks I found a job in a research company. Within weeks on the job, I got shopping raises.
- I went from \$35/week to \$140/week having discovered calculation errors and translating a contract letter from German to English.
- I found an apartment for \$19/month
- By November 1960, I was a college student carrying double load of credits (I was in a hurry ...) at New York City's City College.
- Within two years, I became a research assistant at NYU
- Within six years (1966), I became an operations research professor at NYU-Poly with the rank of Assistant Professor.
- (f.) By 1968, I formed my first high tech company. With each invention (most patented) I formed a company to capitalize on it.
 - A separate manuscript ("The Ride on the American Business Highway") descries multiple projects / inventions and their fate. Very little in life provides a "high" resulting from inventions that work.

(g.) I have earned the right to my opinions in this booklet by virtue of the vast research and invention efforts in security systems, massive communications systems, the "StarWars Computer Project," medical inventions and others which were generated for and with:
 ADP, Air Force, American Express, AT & T, Burroughs, CBS, Citibank, Exxon, IBM, Singer and others. The Business Book cited above produces an accurate report regarding on successes (no technological failure ...) and failures (some associated with falling in love with projects that should have

been kicked out quite early.

VI.1 Fundamental Opinions

These will be expressed and justified by PGC publication of its booklets.

(A.) A Holocaust doesn't just happen. It is an end point in a sequence of pogroms / atrocities / massacres / genocides.
 PGC provides justification for the substance of this opinion.

- (B.) No other group / tribe / nations, except for Jews, has ever had a Holocaust thrown at them. PGC provides the prerequisite requirements for a Holocaust.
- (C.) The <u>primary requirements</u> for a Holocaust to occur must be the existence of a Totalitarian / deterministic / utopian cult as the midwife capable of malignant mindset / nearreligious satanic convictions – deeply held in serving a major humanistic benefit urgent to attain.

(D.) The most satanic requirement justification for a Holocaust is that all actions perpetrated against the hated / despised group <u>be legal</u>.

This strange requirement applied by the Nazis against the Jews provides the ultimate singularity inherent in the Nazis extermination of Jews plan.

An example will illustrate.

Christina Sternberg is the Author's wife and a Founder of PGC. Her grandfather (Dr. Theodor H. Troller – "TTI") was a country doctor in the Sudeten region of Czechoslovakia populated by aa large German population contingent. TTI was born Jewish; his father was a Rabbi in Prague. TTI has converted to Catholicism and married into an industrialist German family.

Once Czechs were delivered to Germany by the British / French appeasers' group, TTI became a "Prominent Jew") by 1935 Nuremberg Laws. "The Trollers' Wars," a primary manuscript of PGC's Knowledge Base, describes how essential these laws were to Nazi policy.

Page 26 By these laws, the daughter of TTI (Dr. Augusta Hoffman) would become a "Privileged Jew"

TTI was a feisty character and, in Nazi courts, fought valiantly denying the paternity of Augusta. She survived the war. The Nuremberg Laws dealt with German Jews who were either soldiers in World War I or were otherwise "important" due to their achievements.

The Nazis, obeying their Nuremberg Laws, displayed other strange characteristics. They increased TTI's pension by 60% when it was required by law and, not much later, stopped paying him altogether "by law."

VI.2 The fundamental opinions, defined in VI.1, lead to the formal ancillary opinions PGC holds based on evidence supplied by the numerous institutions conducting the Holocaust research attempting to meticulously describe the what / how and why did the Holocaust happen. Augmenting the vast research of stellar institutions is a wide array of opinions provided by PGC-like smaller researchers who provide practical questions in need of answers and practical plans of attaining answers.

PGC's practical opinions are provided by category.

The categories are straightforward.

- Page 27
- (E.) There must be an umbilical cord between diaspora Jews and Israel.

It seems obvious that Israel has been for decades a safe haven for Mideastern Jewish refugees, for Argentinian and French Jews to massive Russian Jews.

Israel has demonstrated that hurting Jews is quite expensive.

Israel has demonstrated that it can not only absorb escaping Jews, but integrate them into the technologybased economy and <u>become a technological superpower</u>.

- (F.) It is not difficult to demonstrate a host of benefits that Israel can and did bestow on
 - •• <u>Jewish youth worldwide</u> being proud to be nonvictims for a long multidecade periods totally obliterating two thousand years of self-pity.
 - •• <u>Aggrieved tribes worldwide</u> that the Oslo syndrome won't be operative and the anti-Israel resolutions machine at the U.N. is a farce.
 - •• <u>To all who'd listen</u> that hurting Jews is expensive
 - Multiple terrorists' leaders discovered that sleeping twice in the same bed is dangerous
 - Idi Amin's Air Force was gone; Iraqi and Syrian nuclear facilities were gone.
 - Payback memories are long and revenge is sweet.

(G.) But not all is hunky-dory in Chelm, Boyberik, Yehupitz and Casrilevke and in Israel itself.
Saying: "Well, not everything can be perfect" is just a waste of breath. Of course, it is true.
PGC has worked hard and will continue to deal with intellectual garbage. And, in some case, refuse to take prisoners. Some simple examples will illustrate the problems we wish to emphasize, some we wish to help solve, and many others just lower the temperature and continue collecting the garbage with hope of lowering the smell.

Some of the examples we use are just plain obnoxious and need treatment now.

- Example 1. North Korea is a cashless, brainless, foodless abomination of a country which is a member of the nuclear club. Decades ago, a U.S. president, members of the U.N. Security Council promised the world that N. Korea will never own nuclear weapons. It is not only possessing such weapons, but has the means to deliver them nearly anywhere in the world.
- Example 2. Iran is an inch away from possessing the bomb. For years now, a succession of U.S. presidents assured the world that Iran will not wind up possessing nuclear weapons and robust missiles to deliver them. PGC's opinion paper "The Iran Deal" convincingly postulates that Iran will shortly possess bombs and their means of delivery. The arguments are very convincing.
- 3. <u>Example 3</u>. The population of the earth was fortunate to have the U.S.A. highly competent sheriff who capably and with huge generosity saved the world from collapse three successive times in the 20th Century. The generous sheriff is tired.

- 4. <u>Example 4</u>. A new coalition has formed consisting of a brooding loser of its former imperial status the remnants of Soviet Union, with a new contender, China, whose clear and obvious goal of economically hurting the U.S. before attempting to rise to the top super status. There is no explanation to the threatening behavior of the new coalition vis-à-vis Taiwan and the other friendly pro U.S. alliance in Asia.
- 5. <u>Example 5</u>. A massive combination of anti-American members of unaffiliated members of regional alliances (African, South American) who wish the U.S. ill.
- 6. <u>Example 6</u>. A massive array of U.N. affiliated world organizations all wishing America ill.
- 7. <u>Example 7</u>. Alliances among huge cartels. (The World Health Organization, The Refugees Agency (UNRVA), The World Court and many others combining with drug and crime cartels.

The above examples are treated by PGC in the multiple singleissue booklets and opinion pieces of the Knowledge Base. Other negative indicators dealt with by PGC fall into the following categories:

(H.) The many a time vicious fighting among Jewish organizations.

This category is serious.

The fault lines consist of serios ideological / political issues (e.g., Progressives vs. Centrists and Right Wingers differences of religions / cultural nature, serious differences re Israeli policies and wider cultural differences stemming from the interactions of all the categories above.

For instance, for quite many years now a wide-ranging argument among Jewish organizations concerned moving the U.S. Embassy from Tel Aviv to Israel's capital, Jerusalem ... One group argued that this is not just a frivolous desire. In many ways, it illustrates to all that a country refusing Israel's desire indicates other "Israel Annoying" actions such as frequent frivolous anti-Israel votes. The argument re Jerusalem gets further hot when another group accuses Israel supporting Jews of disloyalty to the U.S. in many ways that do not support American interests of not riling up the Mideast Arabs and worldwide Muslims.

(I.) Similar arguments swirl around U.S. policy vis-à-vis Iran. It is hard for anyone to ignore Iran's role in worldwide terrorism support, and yet the Obama policy of attempting to move Iran "moderates" away from enmity of the West is a worthwhile effort.

PGC has generated several in depth policy papers attempting to realistically deal with Iran.

Jewish organizations, political / cultural / social are effective warriors for their causes, are well managed, have financial and lobbying muscle and where it is dear to them, they are precocious.

This capability poses serious problems for trouble makers and for Israel, in multiple ways.

PGC is too small, too young, too poor in resources to be pretentious to touch on this subject at all.

HOWEVER,

It may not be able to tell the emperor how to dress and when, but it is quite able to tell the emperor that he is naked and there is a wide supply of clothes to wear to cover the nakedness.

In the arguments that follow, we try to get rid of unwise / silly arguments by Jews about Israel.

(J.) One of the worst diseases is false self-hate.

Surprisingly, the presently available knowledge contains all the data necessary to confront the naked emperor. In the next few years, PGC will improve our arguments further. J.1 The United Nations is a specifically helpless organization. <u>From its inception, immediately past</u> <u>the end of World War II, it starts to assume the role</u> <u>of "World Government."</u>

It is a sprawling, huge organization with authority to legitimatize countries, secure borders, provide multiple economic support to numerous countries. It has units responsible for legal adjudications, controlling military / security support to protect aggrieved countries and handle refugees' wellbeing.

In the last few days, the U.N. behemoth is attempting to grab the supreme role of organizing the world to solve the worldwide CO₂ emission problems and the fearful disasters of climate change.

The U.N. is the ultimate ineffective organization that other than filing elaborate, flowery illogical speeches cannot find a single act / deed or thought that it can actually contribute to world order and wellbeing.

- •• The first example below illustrates the U.N.'s "Idiot Math" knowledge.
- •• The second example that follows identifies the U.N.'s "Idiotic Health" knowledge.
- •• The third illustrates its absolute ignorance of anything economic.

J.1.1 Math for Idiots

Within a short period, <u>likely less than one year</u>, the U.N. is likely to generate

A general International Climate Control Authority (Don't worry, even the name will be screwed up) which will make it an international law. Please note that the sheer structure of the form provides numerous <u>data</u> <u>cheating opportunities</u>.

The above is true by definition.

- There probably does not exist a single country that known today how much it emits in CO₂ tons.
- There is much doubt that next year's data will be a more accurate forecast.
- Thus, it will take several years (maybe 10 years, to think conservative) to have emission that are worth asserting in "our fictional form."
- Signaling virtue and <u>not performing actual virtual deed is an</u> <u>abomination.</u> Hence to have a good start on emission reduction:
 - (1.) Cancel Davos
 - (2.) Turn the Al Gore's mansion lights off so we couldn't see it when we fly over high
 - (3.) Plant bamboo trees
 - (4.) Have John Kerry and Buttigieg stop flying private jets and hundreds of more little things.

But most importantly, consider the following idiot math.

Make the following logical assumptions:

China has been growing its economy (Civilian and military) at a huge rate, say 8% per year. China does not have large reservoir of oil and gas.

To sustain its growth (or let hundreds of millions go hungry, fast trains crawl with little passenger load. Multiple centrally planned cities with ten million inhabitants to stand empty and be occupied by rats and other unacceptable consequences) China must have the absolutely clear choice of using coal for some time to come and, as every Tom, Dick and Harry know, the CO₂ and particles (harmful to health) makes not only for health dangers but lowers standard of living and due the earth rotation delivers emitted pollution all the way to the U.S. (estimated up to 40% of pollution in Western U.S. is sourced – to a large degree in China.

China is not the only country whose growth rate require massive energy. India is right behind China in its thirst for energy which they don't have in abundance.

To a lesser extent, large population in Asian countries need growth and have not enough energy sources on their territory.

Add the largest South American country --- Brazil – which has been for several decades decimated huge virgin forests (which absorb CO₂ and produce vital oxygen) who add to wild hunt for energy sources.

None of the mentioned countries in will at any time soon agree to eliminate any of their emissions. As much as U.S., E.U., Western Democracies, the U.N., any international and regional political and economic bodies would beg, cajole, threaten and nicely ask, no shortterm actions will be taken the huge mention hungry-for-energy countries.

China and India continue nonstop building and utilizing coal generating electric production plants.

If the above situation weren't bad enough from emission redaction point of view, <u>idiot math produces tearful results.</u>

Assume that for any year that China requires 8% of economic growth, and this translates to only, say, 6% increase in energy consumption (this is an optimistic wish which incorporates some advances in energy use) and, subsequent years are a repeat.

No matter what any wishful thinker re China says, it might take, say, five to ten years for China to achieve the first year when it can actually thin of being effectively balanced between availability and use of energy.

This is the point where China will begin to afford to think about the entire remediation effort and breathing cleaner air.

Neither China, India nor Brazil and other large energy consumers can basically become "Good Citizens" and work on environmental cleaning while heavily struggling with their direct energy need.

Thus, unless the U.S., E.U. and Western energy powers like Canada, and North African oil / gas rich sheikdoms can cause enormous investments in cleaning the air <u>and</u> having ample <u>new</u> energy, NO REAL CLEANING CAN OCCUR.

By the time China, India and Brazil reach a point when they can afford to start serious cleaning efforts in support of "U.S. and friends" cleaning an <u>earth which is, by then, dirtier than now.</u>

Even "Idiot Math" suggests that for everybody's sake, the work should have started long ago.

But U.S. foes and unreliable friends wanted the U.S. to pull the entire aircraft carrier forward by U.S. only.

It is not difficult to insert even more pessimism to the above idiot math theorem.

This added furuncle postulates that China, whether it wants to or not, will join a pact with Russia for reliable fossil fuel supply – no matter what the U.N. will say or do.

It may require China to incorporate Iran into their pact because of its oil supplies and with threats or even partial actions re Taiwan, China can force the U.S. and its Allies to increase to huge proportions their militaries leaving trillion dollars needed for new reliable technologies waiting for better geopolitical conditions to prevail.

The entire idiot math mechanism is geared to have U.S. and many unreliable friends put up the initial trillion dollars which will bankrupt the U.S. contingent and allow "China and Co." to rise in the geopolitical ranking while the poor smaller countries suffer, together with U.S. and company from obnoxious unhealthy CO₂ pollution and being economically devastated.

The U.S. has been, for the past 100 years, the engine and the catalyst for high tech innovation. Idiot math creates the insane notion that the world will be cleansed without the real innovator's muscle.

Well, it is time to return to unwise U.N. players – the only idiot players the U.N. produces – and finally pay a visit to the unwise Jews.

PGC extended major efforts to show how the major components of the U.S. are nearly-by-definition, incapable to understanding the problems they undertake to solve and invariably don't understand the solutions they cling to.

Huge massacres keep occurring in North Africa, Mideast and deep Africa. The U.N. relegates the solving of Christian massacres by the malignant Assad rulers by sending a Sudanese General who did the Darfur massacre.

The Iraq / Iran war between two demented regimes cannot be explained. Iraq's burning of every oil well in Kuwait cannot likewise be explained other than a serious attempt to explain that 11,000 Iraqi generals need employment.

Especially incompetent are U.N. "Peacekeepers," interventionist U.N. in the slave labor practices in Africa, in South America.

China was the host, some years ago, to U.N.'s celebration of "The Year of the Woman." China has been killing female babies ONLY because, otherwise, grow up females!

The World Court could not, for three years, indict Milosevich, a notorious criminal killing Bosnians. Iran received \$20 Million for its "Peaceful Nuclear Research." The World Health Organization issued hundreds of successive purposely erroneous health guides including "closing up" countries, closing schools.

The worst recent U.N. shenanigans are associated with appointments of leadership in all the components of the U.N. (WTO, WHD, UNRWA, UNESCO, etc.) based on overwhelming votes of favor seeking U.N. members looking for Chinese support.

A dysfunctional U.N. has an especially deleterious effect on Israel and the Jews.

The next few years are likely to disclose the real problems facing Israel and the Jews. PGC forecasts that the coming Centennial of the Holocaust (2035) will be flooded with numerous U.N.'s country members wishing to actively participate in the memorial's planning. This forecast is based on simply known facts:

Germany has tried for many years to Jettison the Cain stigma. It made Herculean efforts to atone for the worst crime.

Poland, Rumania, Hungary and others have tried some cures but remain upset about still carrying the stigma.

A major U.N. sponsored shindig cannot make forgiveness happen.

As is typical with the U.N., mixing all sizeable criminality in a single pot makes for many demands of a vast number of aggrieved people seeking "justice" – China suffered from Japanese atrocities, Korea suffered under Japanese criminality, former Warsaw Pact countries suffered from Soviet criminality, is not easily forgettable.

What the aggrieved also quickly forgot how they were saved by the U.S. from decades of atrocities cannot be all put together in one fell swoop.

PGC points out in numerous opinion pieces that the three Totalitarian huge wars of the 20th Century with the recent rise of China plus remnants of the Soviet empire is newly acquired potential subordinates will create a new set of confrontations. No shmaltzy speeches will do any good. In the absence of a better U.N. term, PGC calls the confrontation that is coming as "The Battle of Civilizations."

With much humility, PGC has a few practical suggestions of lowering the temperature of the coming confrontations.

Remember, not long ago, the ozone layer crisis came and went ...

PGC is, at present, producing a very specific plan for very structured centennial presentations that are Jewish centered, with a clear goal of outlining the crimes that Totalitarians commit and offering ways of limiting such crimes.

However, hundreds of U.N. and its affiliates resolutions are directed by the U.N. at Israel – knowing full well that they are false – are not easy to stop.

The worst of it, one logical fallacy – the one that is strictly a "repetitive lie" – requires special treatment. This treatment requires "<u>Treating"</u> <u>many</u> unwise Jews.

An example will illustrate.

Many Jewish organizations provide Jewish youth with an opportunity to go to Israel to strengthen their connectivity to this miraculous little country. Usually, a wealthy donor provides his plane for a round trip. Another, not so wise, Jewish organization demands that the visit must incorporate exchange of views with sworn enemies of Israel's existence. The truth is that Israel's enemies shamelessly lie (e.g., Arab children's access to medical facilities and other awful lies). The numerous examples point to the existence of a sizeable contingent of unwise Jews, all over the place.

Although it is quite known that no saints reside in the Mideast (and that includes Israel), it is also well known that the repeated attack (physical, political, economic) on Israel are prima facia obnoxious and unwise Jews are always there

Well, after two thousand years, cops and robbers in Israel are (75% of them) finally Jewish.
