- In 1968, Married Christina Troller (“CTS”) – The Daughter of a World-Class German Technologist (Aerodynamics)
Her Father – Theodor H. Troller II (“TTII”) Disinherited Her for Marrying a Jew. Christina Converted to Judaism.
- TTII, as it turned out, and after everybody forgave everybody:
 - ▲ Had Jewish Ancestry ▲ Brought to the U.S. in 1931 to head the Guggenheim Airship Institute
 - ▲ TTII was brought to the U.S. by Von-Karman (Born Jewish) who appears on U.S. stamps as “The Father of Space Exploration”
 - ▲ TTII became a prolific inventor for U.S. Defense and received a Commendation for his achievements (“The Army Navy Award”) from President Roosevelt.
- TTI, CTS’ grandfather, died in Theresienstadt Concentration Camp, a “Privileged Jew” after a hellish, day after day, humiliation of an elderly kind country doctor.
- CTS is an accomplished Information Scientist whose professional career spans GE’s Nuclear Operations at Hanford, Nuclear Research in Schenectady (Admiral Rickover domain) at CBS, Shell, and JS’ research companies. She is the designated Information Officer of PGC.

A detailed background of JS, CTS, TTI and TTII is provided in several completed manuscripts

WHY START WITH THE PRESENTERS' BACKGROUND?

- The best way to extract information from an eyewitness is to ascertain clearly where the witness stands. **Let us lay out where we stand.**
 - ▲ The Holocaust is **“Close and Personal”** for JS, his saintly parents and his wife and her father and grandfather. As they say in business: “We have skin in the game.”
 - ▲ JS' background indicates that:
 1. JS won't let a “victim's thought,” a “victim's bone, nor muscle” reside in his body. JS will not whine about the continuous pogroms on Jews, spread all over inhabited areas over 2000 years. With some respites, these pogroms have been a permanent threat. **JS will respect dignified expressions of sorrow and sympathy for our people robbed of dignity and life.**
 2. The Jews, JS' people, have cumulated a wide array of “Blood Libels,” ranging from “Killing the son of God” to “using non-Jewish blood on our matza on Passover.” It expands to being physically dirty, cheating in all our dealing, and striving to take over the world. **JS will no more care why someone hates Jews and will MAKE IT VERY, VERY EXPENSIVE TO HURT JEWS (if he can).**
 3. In the same way that Jews remember, **every year after year**, the exit from Egyptian slavery, Jews memorialize the Holocaust. **The big and highly important Centennial Memorial is quite close. IT BETTER NOT BE ONE MAMMOUTH WHINING SET OF EVENTS. Everyone knows that one cannot, and should not, stifle the deep sorrow part of the memorial, BUT IT MUST BE BALANCED BY INCORPORATING THE TSUNAMI OF HEROIC DEEDS by Jews and honorable non-Jews. PGC thoroughly deals with this aspect in this presentation.**

- ▲ JS' analytical background further indicates that a complex phenomenon, as the Holocaust is, DOES NOT JUST HAPPEN.

4. There are three questions that need good answers.
(a) What happened? (b) How did it happen? (c) Why did it occur?

The perfectly verifiable facts are near infinite and are widely available from impeccable sources. The largest research project ever undertaken has been in progress for 77 years attempting to answer the above questions, with special emphasis on “Why?”

PGC's stand is dictated by an overriding objective of helping, even in a small way, the avoidance of repetitions of pogroms, atrocities, genocides and even another Holocaust by nailing down causality.

5. In multiple JS lectures (over 100) delivered to audiences (attended mostly by Jews) in south Florida, it became clear that the knowledge re “The Holocaust” was frighteningly small.

PGC has an obvious stand of emphasizing a significant push to deliver clear answers to the three questions.

PGC IS UNHAPPY WITH SOME CURRENTLY AVAILABLE ANSWERS.

What is Known/Unknown About “The Holocaust.”

A massive, biggest ever, Research Project ongoing for 77 years.

▲ The research project involves:

– Literally thousands of institutions worldwide:

- Multiple government supported institutions
(e.g., U.S. Holocaust Museum, the Israeli Yad Vashem
and many others in multiple countries)
- Stellar universities worldwide
- Think tanks worldwide
- Endowed projects of multiple types in multiple venues
- And only God knows who else

– Literally tens of thousands stubborn qualified historians and all the soft sciences researchers looking at the multiple aspects of this phenomenon.

- As a result of the unquestioned competence of institutions and researchers, **a seeming consensus has developed re the answers to the three main questions.**

**WE QUESTION THE CONSENSUS!
AND HAVE SERIOUS ISSUES WITH SOME OF THE ANSWERS.**

The Answer to “What Happened?”

- The seeming consensus answer is (roughly):
“Six million Jews were killed by the Nazis during the Second World War”
 - ▲ The stated fact is true. However, it is, regrettably, incomplete. It does not convey the following information:
 - It does not convey the singularity of the set of events known as “The Holocaust.” Stalin and Mao killed more people, Pol Pot killed more people (proportionately to Cambodian populace) and their deeds were not deemed as “Holocaust.”
 - Historically, in the past, say three millennia back, huge empires in the Mideast had regular jousting matches. Winning meant capturing slaves and parading them and the acquired booty when returning victorious. The singular Nazi project was set to exterminate the Jews and annihilate them all.
 - In the more recent past, atrocities involving religious wars and/or territorial/colonial expansion, the losers could surrender, give up territory or religiously convert and thus spare their lives. The singular Nazi project left no option other than certain death.
 - The worst of it all was the Nazi immense effort to maximize the humiliation and pain prior to and during the extermination process.
- The seeming true consensus answer to “What Happened?” raises some questionable/reasonable issues: What did the Nazis do that is singular/unique to their manufactured atrocity to make it a Holocaust? After All, Holocaust Don’t Just Happen! After All, Only One “Genuine” Holocaust Occurred.
- Attached is PGC’s draft of the answer to “What Happened?” the professionals at the great institutions could definitely improve PGC’s draft.

- The Alternative [“Less Consensus”] Meaning of the Term “The Holocaust”
 - ▲ “The Holocaust is the Final Set of Events in a long, 2000-year sequence of pogroms, atrocities and genocides directed specifically at Jews in Asia, North Africa and Europe.”

Being directed at Jews as a “Race,” it culminated in the extermination of six million European Jews in regions ruled by Germany in World War II (“WWII”), primarily between year-end 1941 and mid-1945.”

It is a singular event, which unlike any other massive killing event, involved enormous allocations of resources in a multi-front war, meticulous planning due to significant shortages of fuel and raw materials, shortage of manpower and continental size handling of logistics.

It was, worst of all, executed by a cult, stubbornly clinging to a near-theological belief’s flimsy excuse for unprecedented hatred, utmost humiliation and maximum pain accompanying exterminations.

“In its wake, it left a seriously disoriented Jewish survivor population (in the millions), a vast number of non-Jewish people of honor who couldn’t grasp a country gone berserk, a strange and sick admiration for the Holocaust implementor’s detailed orderliness (ja, ordnung ...), paving the way for a smart imitator who “cloaked” subjugation of peoples with Totalitarian Kool Aid and who extended maximum effort in the 46 years it lasted (1945-1991), to make the U.N. dysfunctional and as refuse left a whole thriving small-fish-Totalitarian U.N. membership cling to the wish of a world government and a new world order with a cancelled past.”

- It Seems That The Holocaust Didn't Happen By Itself

The Undisputable Fact Is: The Holocaust (or "The War on Jews")
Was a Major Component of a Four-Pronged War.

- ▲ The outstanding Cambridge Historian, Adam Tooze, has shown that in 1942-43, the Nazis were facing: (1) West Europe cleanup (2) Mired in East Europe, and Russia specifically (3) Stuck in North Africa (4) "Industrial-Strength" extermination of Jews, And This They Treated Seriously!

All the fronts faced (1) Huge logistics problem (2) Manpower shortages
(3) Shortage of fuel and materials (4) Deranged emphasis on
a war with Jews

- ▲ When shortages of manpower happened in the U.S., Rosie the Riveter was called and came to the dance.
Not only that, Rosie could pilot the planes she helped to produce all the way to embarkation ports.

It turns out that the highly acclaimed mostly educated population, the seemingly brilliant military, the brilliant/inventive industrial sector, the stellar academies, the legal profession and the truly deranged psychiatric/eugenic "Science" cartel all marched to Hades to the Nazi siren song.

In the huge two-decade preparation effort to launch a small "warrior company," PGC Founders have generated research papers, books, film scripts, plays and (yes) propaganda. It is now all ready for launch.

The Answer to “How Did It Happen?”

- The Obvious and Seemingly the Consensus Answer is Rather Straightforward
It is the Meticulous Preparation behind justifying the eradication of Jews – IT ALL HAD TO BE LEGAL, it was imperative for the survival of the Aryan race, it was required to secure a 1000-year Reich and it had the element of helping humanity to improve the human stock (How impressively important ...).
 - ▲ Meticulous preparation started with securing detailed information
 - Ridiculous Example: How many of the cursed Jews are in Albania? They knew.
 - Early and methodical studies of the chains of ghettos and camps of different function of directing Jews to the death camps. **The studies included the geographical locations of the different camps – why were so many in Poland???**
 - Early studies of the mechanics of extermination
 - Tremendous preparation of the SS Corps – management and lower ranks – for the running of the different types of camps (including Theresienstadt – a “POTEMKIN VILLAGE” – type camp to justify the propaganda notion that Jews are treated well)
 - ▲ Meticulous preparation incorporated the wide use of a huge number of psychiatrists and eugenicists that, together with fully degreed legal and other professionals constituted an incredibly large contingent of the SS.

The idea that the SS were just malignant halfwits prone to extreme discipline of obeying orders is ridiculous. They had more Ph.D.'s than we could imagine.

PGC will deal with this aspect.

- It Took More Than Just Extensive Preparedness to Make a Holocaust Happen.

They actually tested every aspect included in the preparation plan. The Nazis conducted actual “Live Tests.” Although they killed thousands of Jews in the end of 1939 to the end of 1941 period, they used this period to live test the massive exterminating rate in 1942-1945. A numerical example (with conservative numeric assumption), will illustrate:

▲ <u>Assume</u> (conservatively)	<u>9/1939-12/1941</u>	<u>1/1942-5/1945</u>
Total Jews Exterminated	140,000	5,560,000
(roughly) number of days in period	<u>750</u>	<u>1,250</u>

	<u>Just Under 200/Day</u>	<u>Just Under 5000/Day</u>

- Although PGC Raised a Few Questions so Far, **Nothing surprised it more than the attempt to deal with the third question: “Why Did It Happen?”**

The Answer to “Why It Happened?”

After 77 years of Herculean efforts to “Close the Deal” on the causality of Holocaust beast, the answers – in PGC’s view – are quite unsatisfactory. This conclusion requires a significant doze of chutzpa (“plain gall”) mixed with humility (given the unquestionable stellar institutions and researchers who are smart and thorough).

- First, we try to exercise some chutzpa
 - ▲ Since we all just about know that the mammoth Holocaust crimes did not just suddenly happen, we examine the Holocaust as an end stage of a 2000-year known sequence of continuous (with respites) pogroms against Jews (specifically) in nearly all inhabited areas on this globe.
 - ▲ We all also know that the Jews “acquired” immense “Blood Libel” characteristics – these are specified in PGC’s prepared books and papers – which (when cumulated “Blood Libels” are amassed) evoke significant hatred of Jews.
 - ▲ It does not require too much intelligence to know that Totalitarian regimes always need an underlying hatred of an enemy which allows such regimes to unite the populations they rule and execute obnoxious atrocities.
 - ▲ Knowing full well that we could not, as a small company, be capable of providing many answers to the questions we pose, DOES NOT – AND WILL NOT – PREVENT US FROM THE FOLLOWING VIEWS which we back up with some strong factual-based information.

Consider the Following:

- There exists a flimsy near-consensus regarding the entire hyper anti-Jewish “Theology” of the Nazis. We all know the central mantra: “The Jews present an existential threat to securing the 1000-year Reich by threatening the purity of the Aryan blood.”

- ▲ We believe that ONLY TOTALITARIAN REGIMES, believing in a deterministic future, sticking like glue to policies that dictate “using all necessary means” to accelerate the determined future, are capable of super-crimes.

We will attempt to show that there exists an umbilical connection between major atrocities and their Totalitarian executors.

- ▲ There exists a fundamental difference between what Japan did to China in the 1930’s, what Assads did to Christians in Syria multiple times, Pol Pot’s atrocities in Cambodia, what Turks did to Armenians and what the Nazis did. Even the devastating crimes of Stalin (with tens of millions dead) don’t rise to Holocaust level – even though he came close.

Christina Sternberg, our designated Information Scientist, **has generated a paper, “The Holocaust” in which she postulates**

- (1.) **What “The Holocaust” means – accentuating its singularity**
- (2.) **Speculating that “Why did the Holocaust occur?” is inexplicable so far: Even after 77 years of chasing for the answer by the stellar people and institutions involved.**

Jack Gostl, our designated Operations/Implementation Chief, has generated a paper dealing with the psychiatric and eugenics cartels in affecting satanic policies and practices that no one but the Nazis adopted.

- Everybody who sees crime films knows that visiting the crime scene is imperative to solving “What”/“How” and “Why” did the crime occur. A fertile visit to a crime scene for understanding the “Why?” of the Holocaust is a must. **Europe is a fertile crime scene.**
 - ▲ **It spawned three (yes, 3) World Wars. The third is the Soviet Empire War (through surrogates) against the U.S. and the Democratic West (1946-1991)**
 - It quickly becomes apparent that nothing like the 20th Century Totalitarians, committing super crimes, has ever been imagined
 - **In the materials prepared by PGC, we postulate:**
 - (1.) The role of appeasers in encouraging Totalitarians’ appetites
 - (2.) Some Colonial past history encouraged the big Totalitarians in gaining allegiances among the smaller Totalitarians, spread like cockroaches, over the globe.
 - (3.) In the wake of the Nazis’ Holocaust, and the Soviet collapse, we have today very strange countries, insane (asylum quality) regimes, international bodies (political, economic, trade, health, cultural and everything else) that the only good thing they can do is file poetic speeches and contemplate unthinkable stupid actions.
 - **North Korea is an asylum that can, on a whim, cause unthinkable Catastrophes**
 - **Iran, that theologically desires Armageddon and can bring it on**
 - **The above two can easily have a nuclear bazaar**
 - The former sheriff that cleansed the European sewer – **three times** – is now tired.

PGC prepared materials that, we believe, identifies some of the necessary steps needed to diminish repeats of atrocities.

- In the process of preparing our materials (opinion pieces, advocacy and other papers), we discovered an interesting set of facts.
 - ▲ The big institutes with all the talent and appropriate budgets are not free to do or say some things that need to be aired.
 - For instance, Government supported institutions cannot say that it is insane to re-sign the Iran deal (“P5 + 1), knowing full well that it leads to Iran having the bomb and the means to deliver it. Worst of all, several MidEast actors will buy their own bombs. We, at PGC, can easily say the above and much more AND WE DO!
 - ▲ There is no question in our mind that the Holocaust’s Centennial Memorial is a very important event for many reasons, for many countries, many peoples and for many Jewish organizations – who, Thank God, have been endowed with organizational, financial and turf-fighting skills to be admired. For instance:
 - Countries like Poland and Lithuania, accused of mistreating “their Jews” badly at various times (e.g., 1939-1941) and many times before. They want and need a “Get Out of Jail Card.”
Poland has an ambitious program to help remaining Holocaust survivors.
 - Germany would love to lose its biblical Cain’s mark. They did much for Holocaust survivors.
 - Russia would love to be on the dais; after all, they heavily contributed to the Nazis’ defeat.

▲ Seeing all that Jewish hubbub to be apparent near Centennial time, many people – on all continents — will want their grievances aired and acknowledged and be a party to major events.

– There is little doubt in PGC’s mind that a U.N. shindig is the worst possible way to memorialize the singular event.

PGC argues this aspect with unusual chutzpa. Do you remember the U.N. celebration of “The Year of the Woman” in China – the country that kills female babies only because they’re future women.

Remember that of the 193 member states, a vast majority, are all members in “The Little League of Totalitarians.”

Imagine the speeches, the committees, the rules of what can be said and who approves what. The flowery speeches will be filed. That they can do.

PGC devoted extensive effort to generate, in a dignified and insightful way, the Centennial Memorial. This effort incorporates:

Professionally Prepared Presentation

and educational materials preceding the Centennial.

-- PGC further proposes to generate a suitable memorial for many aggrieved people – who deserve to be heard – NOT ASSOCIATED WITH THE U.N. LABYRINTH.

The expected (hoped for), successful Memorial should help reduce many aggrieved people’s angst.

- ▲ Finally, and importantly, too many have too much fun in a non-stop multi-pronged attack on Israel in the U.N. and its myriad appendages, in a vast array of academic and cultural institutions and quite vile media outlets worldwide.

PGC has produced background materials to help any and all to understand that, out of the Holocaust ashes, Israel Became a Safe Haven for many Jews, mistreated anywhere.

- It made it expensive to terrorize Jews anywhere
- It made it inconvenient for many Jewish organizations to mouth filthy accusations involving real blood libels, such as prevalent “apartheid.”
- It continues to provide Jewish youth with the backbone and courage needed in too many academies, in numerous countries, to object and act against unadulterated anti- Jewish propaganda and behavior.

Like anyone else, and especially in the Gordian-Knotted MidEast, Israel is Not Perfect – it is just many notches better than anyone else.

Who else became a safe haven given:

- (1.) Continuously threatened re: its existence
- (2.) Spending immensely on its security which would sap others’ will
- (3.) Quintupled its population, generated a GDP/Person higher than Great Britain and France and became a technological superpower
- (4.) In spite of many wars and constant terrorism has successfully convinced many of its enemies to join a changing MidEast.

I remember a parade on Fifth Ave. (New York) on Israel’s Independence Day where a “Black as Coal” Ethiopian Jew Paratroop Officer led a “Brown and White” contingent of soldiers from all over.

I know of an Arab General and a Druze Sergeant under my command, numerous Bedouins in JDF and Yellow people (Vietnamese boat people ...) WHAT AN APARTHEID BLOOD LIBEL!
